

Summary: It is shown here how point-centered processes could have generated all phenomena and the expansion of our universe including non-material consciousness. Dr. James.E. Einstein employed Bernhard Riemann's original conception of an n-dimensional space in an n+1 dimensional geometry. They used measurable extensions to describe space but never defined discrete geometric locations as $n = 0$. Equal-and-opposite potentials cancel to zero while countless 0D process-centered-events organize and orchestrate regeneration, representation, and acceleration for a united 3D universe, instantaneously rejoining all forces in a single field via energy and matter as minds and bodies.

All 0D points in 3D remain united at a single 0D polar-point (as a fourth dimension of space) that most physicists think of as a dimension of time. Both 0D and 4D serve as observer-driven mechanisms, instantaneously 'localizing the nonlocal 3D whole', ensuring its overall integrity and stability, maintaining and manifesting gradations of self-organizing electromagnetic and gravitational potentials between and among all point-centered processes. All 0D and 4D points sustain their 'non-material' absence as the indivisible presence of a receptive/reflective 'primal awakens' that 'all of us' 'can' experience as an evolving, timeless, insightful, all-knowing, mirror-like intelligence - both individually and spiritually.

As a Void must retain its formless nature, all that 'takes form' would be constructed out of 0D points, maintaining their formless unity in ever more complex ways. The absence of form—without need of any force or intention—would continuously 'orchestrate' the extension and expansion of 'form'. We'd experience 0D awareness (throughout 3D) as the basis for our self-centric (subjective) experience while 4D would function as the next-higher level of observer-driven (objective) consciousness. Our experience of 'free will' would be the affect of 0D/4D observer-driven consciousness on 3D geometry, biology, and psychology. Thoughts and activities in 3D would 'ensure' 4D self-consciousness for all living organisms.

If stressful, this would be experienced as pain and suffering (psychophysiological tension). What we attended to and how well we 'paid' attention would have consequences. 4D consciousness of 3D awareness would (therefore) allow us to learn ways of directing our attention. So-called 'free will' would incrementally evolve - as essential to our life-force - and be utilized in ever more meaningful ways.

As 0D/4D is omni-present in 3D, more 0D points influence our comprehension and articulation of 3D. Freedom from suffering would occur (i.e., self/Self-realization) when 0D/3D/4D are aligned (together) as a resonant synergy. 4D objective consciousness could assist our 3D body/mind to unlearn and re-learn habitual behaviors including how to 'effortlessly align with and sensitively embody' a (choiceness) subjective 0D/3D/4D 'awakeness'. Like an imageless mirror, 'we' could unite, reflect, and transform our experience of who-and-what we 'appear' to be by ever more sensitively-sharing the evolution of 'our' consciousness (within a universal intelligence) as (uniquely) individuating minds and bodies, each of us 'ensouling the whole' - spiritually (together). By consciously sharing awareness-of-our-awakening, the delusions of separation would dissolve, enlightening our selves and all of humankind.
